7. To agree cheque signatories

- It was agreed at the March 2023 meeting of the parish council that the existing bank signatories and authorisation rights will stay in place until new signatories are agreed.
- It was agreed that, once the Mandate is approved by Unity Bank, Cllr Nick Moon will take over the authorisation of payments.
- In the event of Cllr Moon being unavailable, it was also agreed that Cllr Taaffe would be given authorisation rights.
- A revised bank mandate will be completed by the clerk.

8. To agree to review the Parish Council's Financial Regulations and Standing Orders

It was agreed that these documents would be reviewed, as Agenda items, at meetings of the parish council in July and September 2023.

9. To review the Clerk's salary and Contract of Employment

- 1) The chairman reported that an ongoing review of the clerk's performance has been carried out.
- 2) In line with the Local Government Pay Scales and the National Salary Award dated November 2022, it was unanimously agreed that the clerk's salary would be raised to the next scale point (SCP 26). This will be effective from 01/05/2023.
- 3) The clerk's Contract of Employment was duly amended and signed by the Chairman.
